Appropriate Disclosure Regulation of Beneficial Owners in Listed Companies



In many collective investment schemes regarding listed shares, the registered shareholders appearing are just nominees for beneficial owners. Such distinction between nominee shareholders and beneficial shareowners causes a lack of transparency in capital markets as well as corporate governance and control mechanisms.


That is why European countries, such as the UK, France, and Germany have enacted and implemented the statutory disclosure of beneficial owners with effective enforcement measures.

However, Japan has not introduced such a disclosure regulation yet, so there has been a regulatory gap between European countries and Japan in this regard. It causes the capital market, structure of corporate control, and governance of listed companies less transparent in Japan. Even in European countries, some discrepancies are found in the enforcement measures against breaches of the regulation.

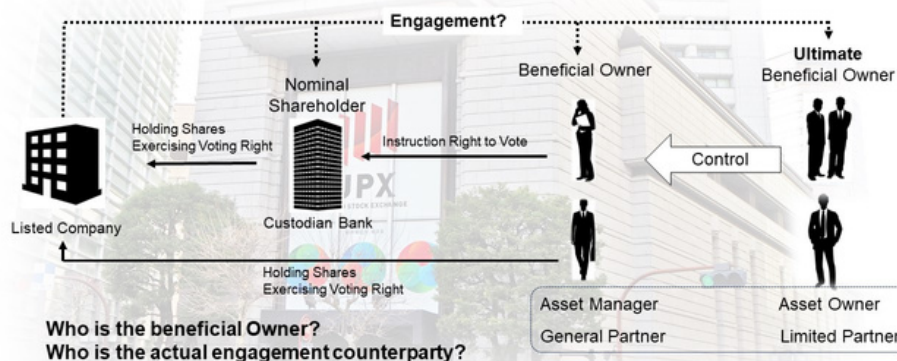
To design and establish the appropriate disclosure regulation of beneficial owner in listed companies, it is necessary to investigate those regulatory differences and their reasons both in theory and practice.

Furthermore, given the expansion of global investment chains, international enforcement against the breach of beneficial owner disclosure rules by abusive offshore investors must be a common serious issue to be dealt with. This workshop is to consider and discuss possible solutions to these issues.

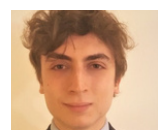
